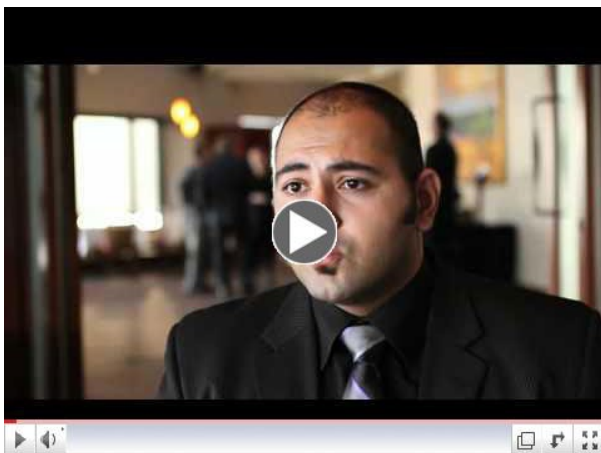

## ranking judicial posts



On September 14, Hon. **Loretta (Hogan) Rush**, JD'83, was appointed to the Indiana Supreme Court by Governor Mitch Daniels, replacing **Frank Sullivan**, JD'82, who retired. Rush was a judge in Tippecanoe Superior Court at the time of her appointment. She will be only the second woman ever to serve as a justice in Indiana.

**Geoffrey Slaughter**, JD'89, was one of two other finalists for the position.

On September 21, the U.S. Senate confirmed President Barack Obama's nomination of Hon. **Gonzalo P. Curiel**, JD'79, as district judge for the United States District Court for the Southern District of California. He had been a judge in the Superior Court of San Diego since 2007.



On September 22, Hon. **Albert Velasquez**, an administrative law judge in the Indianapolis Office of Disability Adjudication, received the 2012 IU Latino Alumni Association's Distinguished Alumni Award. One of the first Hispanic graduates of the Law School, Velasquez "conducts his personal and professional life with all the passion, caring and tenacity that are evidenced today by his many accomplishments," said **Arthur Andrew Lopez**, JD'83, who nominated his mentor. "Few of our Latino graduates represent our community better."



## Center for IP Research to present conference at Oxford



Following two successful conferences on the Bloomington campus in September, Maurer's [Center for Intellectual Property Research](#) is going on the road. On November 2-3, CIPR and the Oxford Intellectual Property Research Centre present "The Future of Design Protection" at Jesus College, University of Oxford, England.

## Seventh Circuit conducts oral arguments at Law School

On October 12, the Maurer community was honored by a visit from the U.S. Court of Appeals for the Seventh Circuit, which heard oral arguments in two civil appeals and one criminal appeal.
