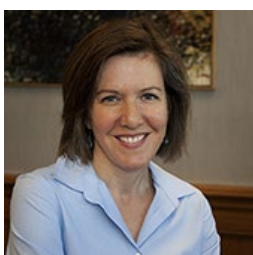

Greetings from Bloomington



The fall semester is well under way! On August 21, we welcomed 200 new JD students to campus. Here are some interesting facts about the Class of 2015: 39% are from Indiana; 19% are members of minority groups; 48% are women.

The students come from 112 different undergraduate institutions; 84 students have worked or studied for at least two years since receiving their undergraduate degree. Among them, they speak 23 different foreign languages, including Farsi, Gujarati and Twi. The class includes a published poet, a national champion in synchronized swimming, a riverboat captain, a grandmother of five and a trapeze artist. The median LSAT and GPA of these students is 164 and 3.80, respectively.

Lauren Robel assumed the role of Executive Vice President and Provost of the Bloomington campus at the end of June. We miss her here at the law school, but she has, as you would expect, already established herself as a dedicated and effective provost. On August 24 a [search committee for a new dean](#) began its work. In the meantime, I am honored to continue serving as Interim Dean.

I am pleased to report that gifts to the Fund for Excellence, our annual fund, exceeded \$1 million this year. I thank you for your generous support of Indiana Law and hope to see you on campus this fall.

On August 7, 2012, Governor Mitch Daniels appointed Rudolph R. Pyle III, JD'00, to the Indiana Court of Appeals. Pyle succeeds his mentor, Hon. Carr Darden, having served as Darden's clerk from 2000-2004.
