IU recognizes Ochoa as a Wells Professor

Indiana University has named **Christiana Ochoa** as its Class of 1950 Herman B Wells Endowed Professor. The selection recognizes outstanding scholars and teachers who exemplify Wells' values, including devotion to diversity, inclusion, student learning and academic excellence. Ochoa and chemistry professor Caroline Chick Jarrold were awarded the honor earlier this month. "Professor Jarrold and professor Ochoa truly have carried on the legacy of Herman B Wells," said Eliza Pavalko, IU Bloomington vice provost for faculty and academic affairs. "They are dedicated teachers who earn high praise from students at all levels. They have served as valued mentors for fellow faculty, staff and students and advocates for diversity in their respective schools and the university."



Harvard cybersecurity professor joining faculty

Indiana Law has long been recognized as a pioneer in the fields of cybersecurity and data privacy. The school's rich history is being built on with the addition of **Ian Samuel** to the faculty this fall. A *summa cum laude* graduate of New York University Law School, Samuel clerked for Judge Alex Kozinski of the U.S. Court of Appeals for the Ninth Circuit, and for Justice Antonin Scalia on the Supreme Court of the United States. Samuel formerly served in the United States Department of Justice, in the Office of the Solicitor General, and on the appellate staff of the Civil Division. Before joining Harvard Law, where he has served this past year as a Climenko Fellow and Lecturer on Law, he was the member of Jones Day's appellate litigation practice. He currently co-hosts the influential [First Mondays](#) podcast about the U.S. Supreme Court. "Ian is another example of the tremendous faculty we have hired in the last few years,



and we couldn't be more excited to have him join our faculty this fall," said Dean and James H. Rudy Professor of Law **Austen L. Parrish**. "Our students are going to enjoy learning from one of the nation's premier up-and-coming scholars."

2018 Stewart Fellows named

The Law School has selected 28 students for its 2018 Stewart Fellows Overseas Externship Program. The fellows are spending the summer working around the globe, from Argentina to Vietnam, as part of a unique program offered through the school's Milt and Judi Stewart Center on the Global Legal Profession. **Jayanth Krishnan**, Milt and Judi Stewart Professor of Law and director of the Stewart Center on the Global Legal Profession, said this year's class brings the total number of students who have participated in the program to more than 150. He thanked the Stewarts for their loyalty to the law school and their commitment to educating the next generation of lawyers interested in globalization

"We are so proud of our 2018 Stewart Fellows, because they represent record enrollment in a record number of countries," Krishnan said. "We started with just a handful of terrific students in India and China back in 2010 and have expanded to ten countries. Our students have so many wonderful supporters, including, notably, the Stewarts, and we are grateful to everyone who has helped make this program successful."

Earl Singleton steps down from CLC, into retirement

Friends, family, faculty, and alumni came together earlier this month to honor the legacy of Clinical Professor **Earl Singleton**, who retired this spring after a nearly three-decade career at the Law School. Singleton joined the school in 1989, and was appointed director of its Community Law Clinic in 1991. Fellow faculty members recalled a colleague passionate about helping those in the community, while simultaneously teaching students the joys - and heartbreak - of being an attorney. "There is nothing better than achieving justice for those who have been denied it in some way," he often said. Alumni noted how Singleton helped them earn and advance in careers they now feel rewarding.

There's another court Singleton will be missed from - Assembly Hall, where the towering power forward's presence at the annual faculty-staff basketball game may lead to future student victories.
